■ **NYDIS' Third Annual Clergy Summit – Register Now**

Register now for NYDIS' Third Annual Clergy Summit, to be held on Thursday, June 1, 8:30 am-4:00 pm, at NYU Kimmel Center. The day-long event will focus on best practices for clergy and religious leaders to empower and protect their congregations and communities through disaster preparedness. The keynote address will be delivered by Bishop Charles Jenkins of the Episcopal Diocese of Louisiana. The Rev. David Billings, Coordinator of the NY Office for the People's Institute for Survival & Beyond, and Dr. Lee Clark, author and Rutgers University sociologist, will also be presenting. A panel of local responders assisting with Katrina relief will include The Rev. James Pullings, Pastor of Leviticus Church of God in Christ, Queens, Mohammad T. Rahman, Islamic Circle of North America-Relief, and Linda Reed-Brown, Church World Service. The agenda includes guest speakers and experiential learning through a "tabletop" exercise interspersed with training briefs provided by trainers with expertise in various aspects of disaster response and preparedness. The tabletop exercise has been developed with Disaster Chaplaincy Services and the NYC Office of Emergency Management. There will also be a resource room with disaster planning and response materials displayed.

The event is free – breakfast and lunch will be provided.

Gili Chupak, Director, Katrina Evacuee Recovery, will be among those to receive the New York State Federal Executive Board's 2006 Direct Customer Service Award for outstanding cooperation on behalf of Katrina evacuees. The awards will be presented at a luncheon ceremony from 11:30 am to 2:00 pm on Wednesday, May 17 on Ellis Island. Other honorees include NYDIS Board Members, Ken Curtin (FEMA-Region II) and Hayyim Obadyah (HSC NYC), and from NYDIS's member agencies, Ed Lynch (Society of St. Vincent de Paul), and Renee Hoffman, Julianne Pannelli, Diana doStando, and Xochitl Bravo (The Salvation Army GNY). In total, 21 government and nonprofit agencies and 34 individuals will be recognized for their work with Katrina evacuees in NYC.

■ **NYDIS/Partners Deliver Furniture to Katrina Evacuees in NYC**

On Saturday April 29, thirteen NYC trucks were loaded by volunteers at the World Vision Storehouse in the Bronx. Over 30 evacuee families in four boroughs received essential furniture such as beds, couches, dressers, tables and chairs, thanks to the coordinated effort of 11 agencies: NYC's Office of Emergency Management, Dept. of Corrections, Parks Department, NYCH, World Vision, New York Cares, NYPD Explorers Club, Praxis Housing Initiatives, Hope for New York, Catholic Charities Archdiocese of New York and NYDIS.



■ NYDIS Speaks at Biosecurity Conference Panel

Peter Gudaitis will participate in the "Citizen Engagement in Health Emergency Planning Roundtable" in "The Public's Stake in Health Emergency Planning", a U.S. and Canada Summit convened by The Center for Biosecurity of the University of Pittsburgh Medical Center on May 23, from 8:30 am to 4:30 pm at the Marriott Wardman Park Hotel in Washington, DC. Leaders in government, public health, and disaster management will be advised on the practical feasibility and societal benefits of engaging citizens in health emergency planning in anticipation of the scarcity of life-saving medical resources and the logistical complexities of protecting the well and caring for the sick in large numbers.

■ NYDIS Invited to Trinity's Post-Disaster Roundtable in DC

Executive Director Peter Gudaitis has been invited to speak at a roundtable discussion exploring the interaction between the public and private sectors, the challenges of disaster relief, and the relevant lessons that can be applied to future response efforts. "Reflecting on Katrina, Rita and 9/11" is presented by The Trinity National Leadership Roundtable on Tuesday, May 23 in Washington, D.C. The forum will delve into the role of churches, non-profits, governments and business in disaster relief. The forum has met regularly since the 1970s for Episcopal leaders to discuss issues pertaining to worldwide outreach. The facilitators are Walter Isaacson, President and CEO of The Aspen Institute and Vice-Chair of the Louisiana Recovery Authority and Carl Weisbrod, President of the Real Estate Division of Trinity Church Wall Street and member of the LMDC and a trustee of the Ford Foundation.

The "partner" would provide the volunteers and/or the facility, and ARC would train the volunteers to work in the shelter as a team. The shelters could be located at your church, school or facility, or volunteers could be assigned to an ARC shelter location. Your organization would "adopt" a shelter to run as a team with ARC's support and guidance.

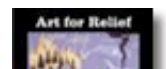

- **NYC Katrina Recovery Update**



FEMA has sent out 3,200 flyers for Katrina Evacuees registered in New York and New Jersey to connect evacuees to case management services. The flyer directs evacuees to call the Katrina Help Line, operated by Catholic Charities Archdiocese of NY, to access the consolidated case management referral service which to-date has referred 225 evacuee families. The Department of Homeless Services, who has contracted organizations to provide case management services to evacuees in the hotels, reports that there are nine individuals and one couple remaining in the hotels with no families with children

remaining.

■ WTC Evacuation Works with NYDIS on 9/11 Unmet Needs

WTC Evacuation Study is currently nominating charities that are working with 9/11 survivors, and will make a donation for every participant to the charity with the highest nominations. They have been interviewing those who evacuated from the Twin Towers, the most comprehensive study of the WTC evacuation ever. People who evacuated from the WTC Twin Towers hold the key to improving building regulations and design tools. The next round of interviews in NYC runs through May 26.

● All Chaplaincy Certifications are Not Created Equal

In the March/April issue of the Association of Professional Chaplains' APC News (Vol. 9, Issue #1), The Rev. Dr. Martha Jacobs, First Vice President of the Board of NYDIS and Managing Editor for "Plainviews", an e-newsletter for chaplains and other pastoral care providers, wrote that she received an email from an organization that was offering to "certify" her as a "Crisis" chaplain. "When I reviewed the certifying requirements, I was surprised that I needed to do so little to be certified, especially in light of what I had to go through to be credentialed by the American Red Cross partner Spiritual Response Team and Disaster Chaplaincy Services, NY." In fact, she found out that the APC had not given permission for this group to use their list, nor had they been vetted by them.

- **We All Can Help Deter the Spread of Flu**

Dr. Isaac Weisfuse, deputy commissioner of disease control in NYC's Department of Health and Mental Hygiene, suggests people practice what he calls "respiratory etiquette." He advises, "...cover your cough, cover your sneezes, wash your hands. Although those sound like old-fashioned things, they are actually important in terms of interrupting transmission of a respiratory agent like flu."

- **NYPD Urges: If You See Something Say Something**

NYPD SHIELD is a program that offers private sector security managers (including security directors of houses of worship) a way to obtain information and engage Police resources. It provides a wide range of training to assist public and private sector entities in



defending against terrorism, keeps them informed of developing situations and special event preparations in the city, and new intelligence and threat information. It is notable in that this initiative advocates a two-way street - information flowing in both directions. During counterterrorism deployments especially, the knowledge held by the public of buildings, blocks and neighborhoods, knowing what belongs and what is out of place, is crucial.
